Demographics of pipeline area

Demographics: “To be affected”

- I. over 6,000 residential homes and many doubled as businesses.
- II. Elementary School abt. 100 feet away from pipeline
- III. Senior/Community Center with pipeline running directly in path of building and parking.
- IV. Las Huertas de San Antonio Land Grant office less than 100 feet away.
- V. Las Huertas Creek (acequia) water right grant (pipeline directly passing in and out through the creek).
- VI. Water Basin – Supplies water to 2 Pueblo’s and to Albuquerque (largest urban City in New Mexico).

Placitas School Children Bus Stops are right in danger zones of pipelines (warning sign's stakes are yards away). Pipelines are classified as high concentration areas.



Pipeline's **Miss**-Management

- Risk Integrity Management (Title 49 USC)
- Are antiquated Codes and need improvements for preservation of properties
 - **CHANGE:**
- Inaccurate record keeping and presentation to the public.
- Double walled pipelines for high concentration areas and water dwelling pipes
- After 40 years of age pipelines should be removed and replaced to avoid explosion/leaks
- A monitoring system (valves every 8 to 10 feet apart) to monitor flow pressure rates for corrosion and leak awareness
- Authority over all lines interstate or intrastate; via State and Federal protections with Operators validating and overseeing at all times, both mandating the safety at all times not a division of inter/intrastate, for the purpose of pointing the finger to “I don’t have jurisdiction” see example in Appendix stating, State PRC agency declining the other Pipelines operating Authority.

ACTIONS:

Placitas residents and surrounding community stands-up to the need to preserve/protect a State of Emergency that is about to happen: The "ticking" bomb about to explode.

ACTIONS:

- Proposal letter to U.S. Department of Transportation
 - Asking for:
 - State of Emergency: Pipelines over 60 years old (pertaining to Placitas but should be over 40 years of age for all pipelines) to be removed/replaced as soon as possible, via owner's expense from profits, insurance, and fines that may accrue via pipeline fines of miss-management, and Federal grants that may be funded.
- New regulations: for change of antiquated Title 49 USC; for Risk Management
- New Federal Bill/State policy
- Make apparent this will go **PUBLIC**
- Hire Attorney: accrual of fines to be pressed against Owner's and Department of Transportation for miss-management of Risk Integrity Management and to the Title 49 USC.



CONCLUSION:

The policy's that have been placed and the policy's that have not been accurately investigated due to "old" pipelines and the issue of an explosion, is irresponsible of the Government and is against our **"Human Rights Act"**

A. Logistics

On October 15, 2014, Western Refining Logistics, LP (WNRL) acquired Western Refining's southwest wholesale business, which included fuel sales to third-party customers, and to WNR's retail and unmanned fleet fueling cardlock businesses; crude oil trucking operations; and a lubricant product distribution business.

WNRL also owns, operates, develops and acquires terminals, storage tanks, pipelines and other logistics assets related to the terminalling, transportation and storage of crude oil and refined products. Headquartered in El Paso, Texas, Western Refining Logistics, LP's assets include approximately 685 miles of pipelines, approximately 8.2 million barrels of active storage capacity, distribution of wholesale petroleum products and crude oil trucking. WNRL began trading on the New York Stock Exchange on October 10, 2013.

Note: Western Refining acquired lines. Fiscal year ending December. Pipeline pre-existing transfer of ownership, no repair of older Pipelines when assessed and transferred. (Flaw to new ownership, insurance is not efficient, removal and replacement of older pipelines should be a factor). Now new owner Tesoro Corporation, should have responsibility to replacement and removal of old pipelines.

2013 Mayflower Oil Spill

Approximately 500,000 US gals



This is the Exxon Pegasus crude oil pipeline break 2013. The Pegasus line was a 65 year old line that had it's pressure increased by 50% one year before the break.

Placitas has the 60 year old Western crude oil pipeline running by homes and our elementary school. BLM gave Western permission to increase the pressure on this line to 800psi WITHOUT ANY PUBLIC COMMENT.

Again, pipelines that are older erupt; Placitas pipelines have gained pressure two years ago and this an State Emergency about to happen, just like this EXXON Pegasus oil break in 2013.

Hi Ty and Barb,

We were just hiking in the open space off Mustang Mesa, and detected a slight smell of gas at the pumping station (or whatever that thing is) not far from your house. We called the emergency number on the fence, and they didn't seem to know where we were talking about. I left our home number and got a call from Jim Noolan at 281-887-2612, who is in Houston. He also had no idea where I was talking about, which I find quite scary and told him so. Then a local technician called us (phone number 505-436-0209), and he also had no idea where I was talking about. I described where it is in the open space and what roads are near there, but I didn't leave the conversation with any confidence that he understood.

I thought you'd want to know about this, since it isn't far from your house, and because the people responsible seem to have no idea what location I'm talking about. The first two didn't even understand where "Placitas New Mexico" is.

Well, I'm trying to do the right thing by reporting this, but with no luck so far on the receiving end....

This correspondence was given to Dwight Patterson who has been leading the Las Placitas Association on the pipeline issue, he is in the environmental realm of sustainability. This negligence and posting of phone number is a flaw to policy to the Integrity Risk Management that is posted on all pipeline Owner's websites. When safety is an issue and nothing is known¹ or done immediately this is cause for a fine and legal action.

This is correspondence Consulting – USA; LLC requested from John McNerney, who’s a member of Eastern Sandoval Citizens Association: ESCA; this is listed in objectives above as a flaw to policy concerning Intra and Interstate. This policy gives only State permission to operate one pipeline and if, one of the other pipelines is malfunctioned it will not be responsible for it, although it is in the same location as the others, will be an oversight and is unethical this flaw in policy from the Direction of the US Secretary of Transportation is an oversight and disrupts the obligation to Citizens in communities that are in the direct front lines of these pipelines and are not valued as Human Rights Issues in our own Government the US where this is mandated to be a just practice.

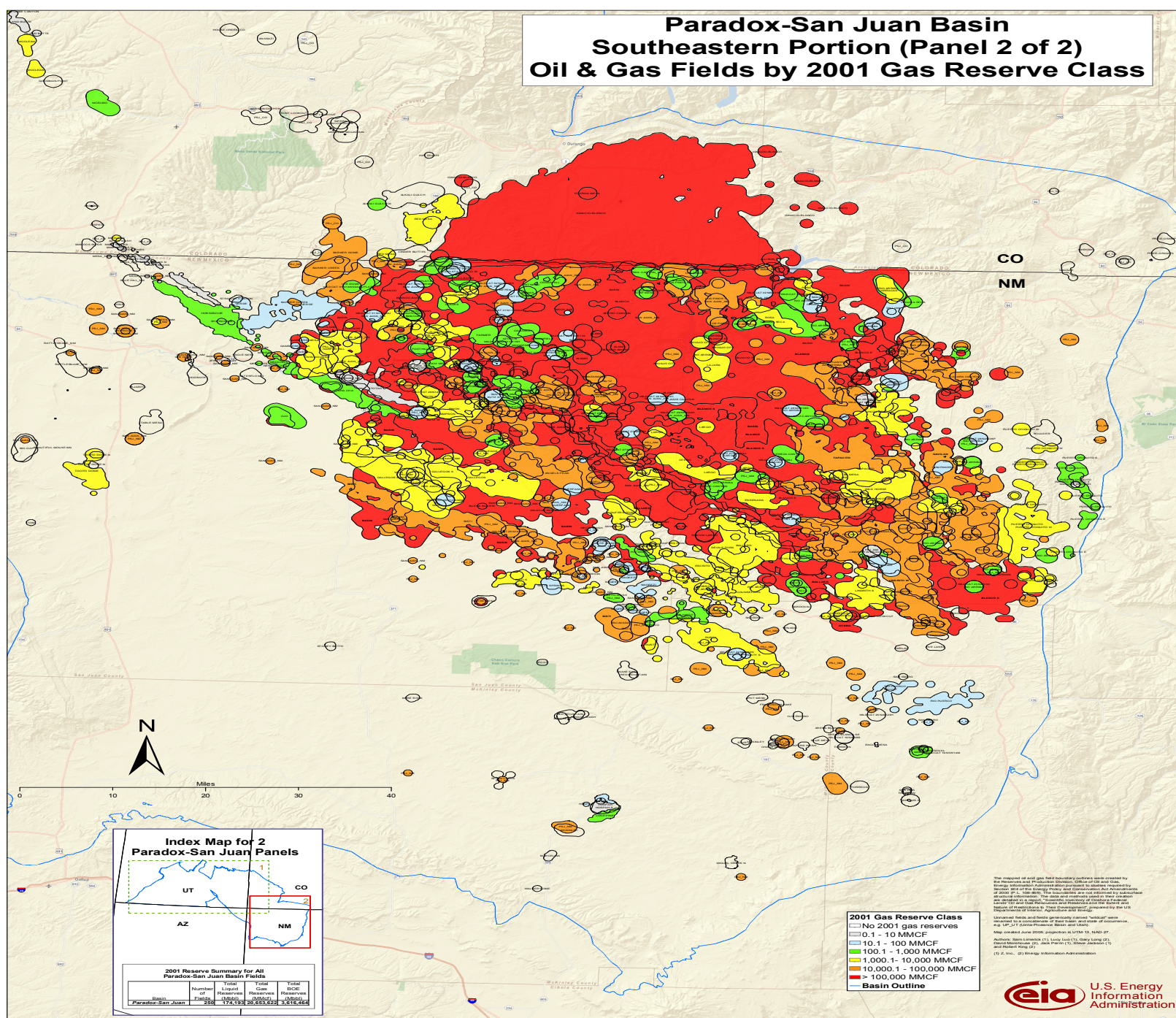

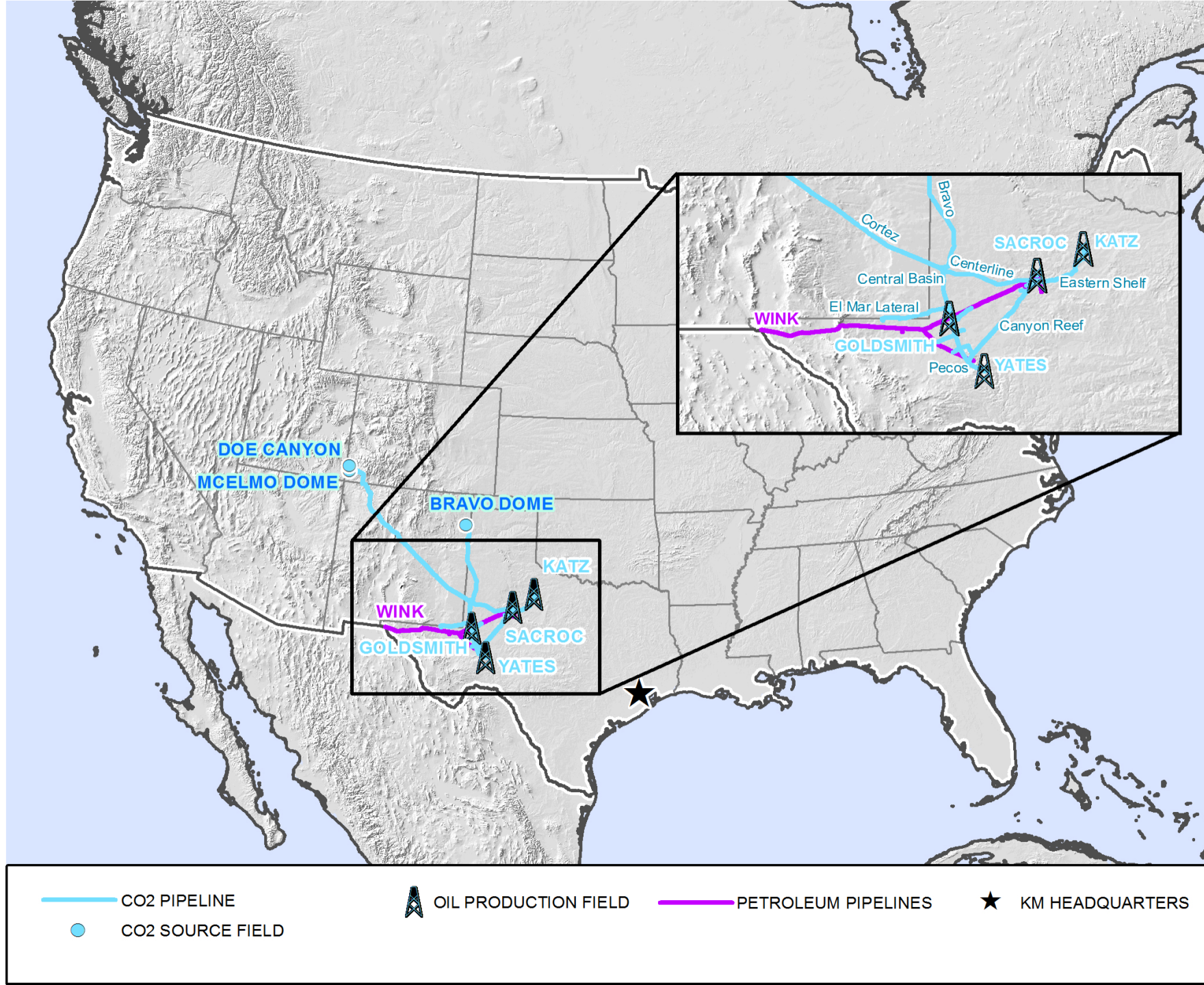

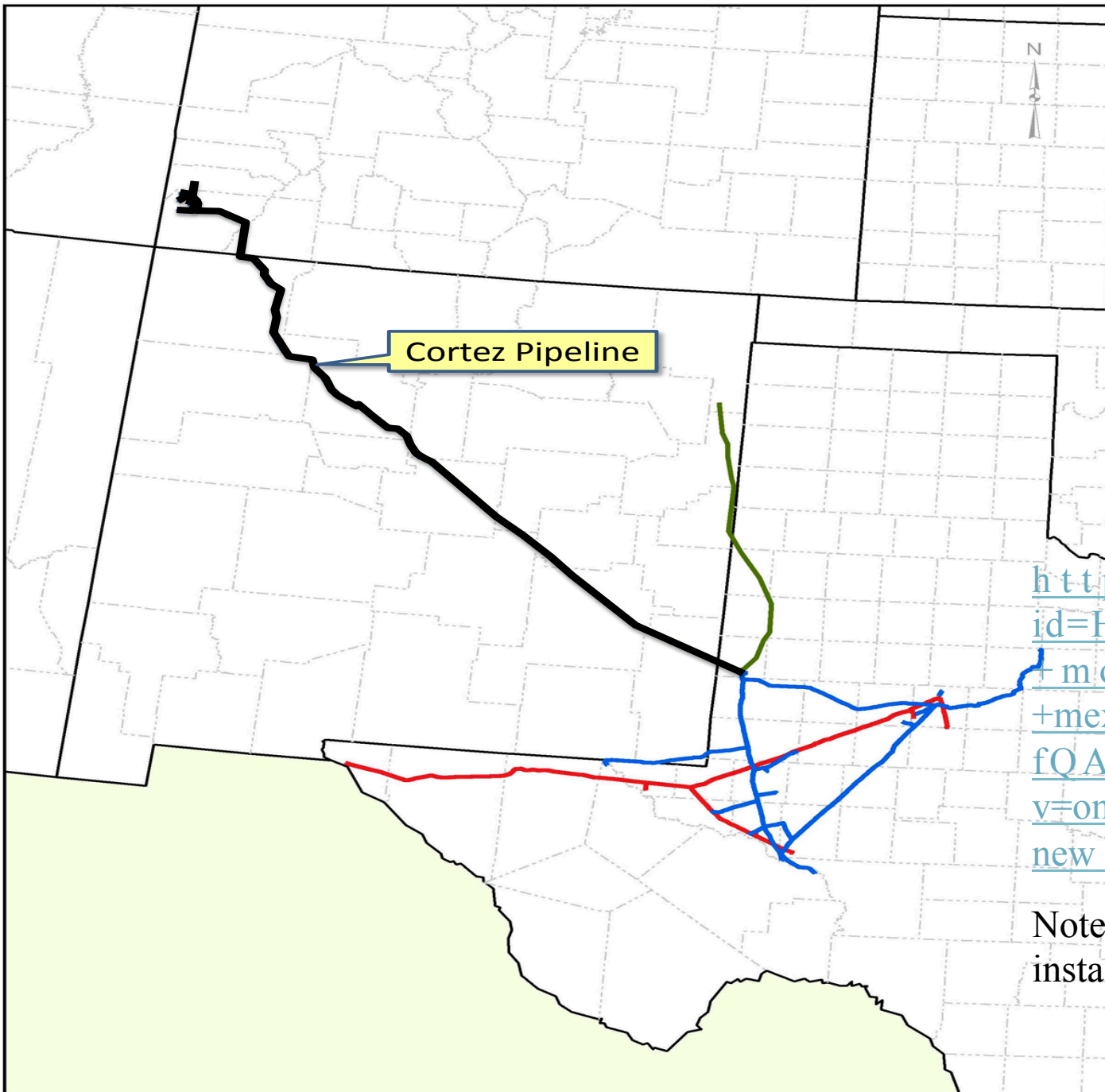

Paradox-San Juan Basin Southeastern Portion (Panel 2 of 2) Oil & Gas Fields by 2001 Gas Reserve Class

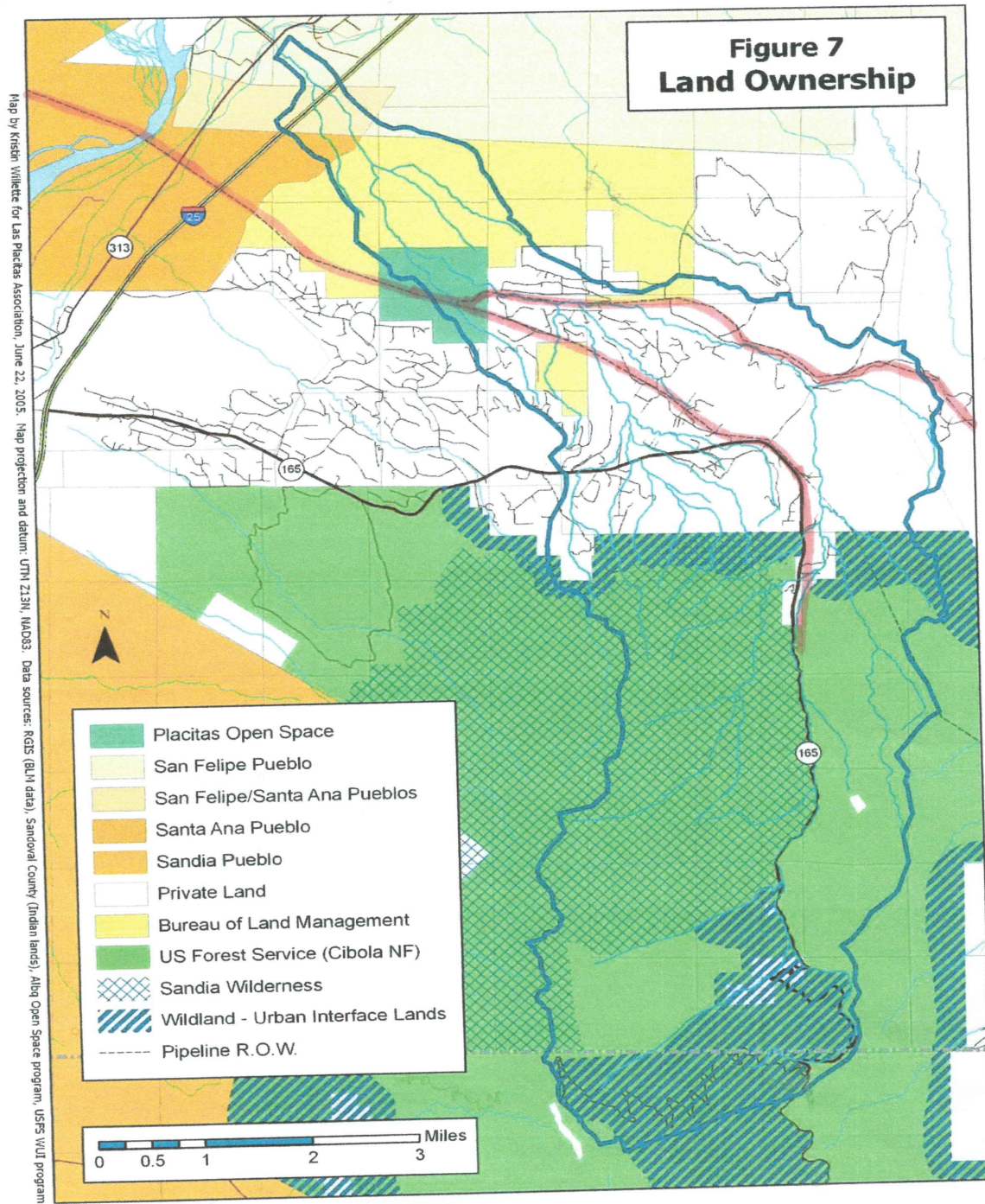




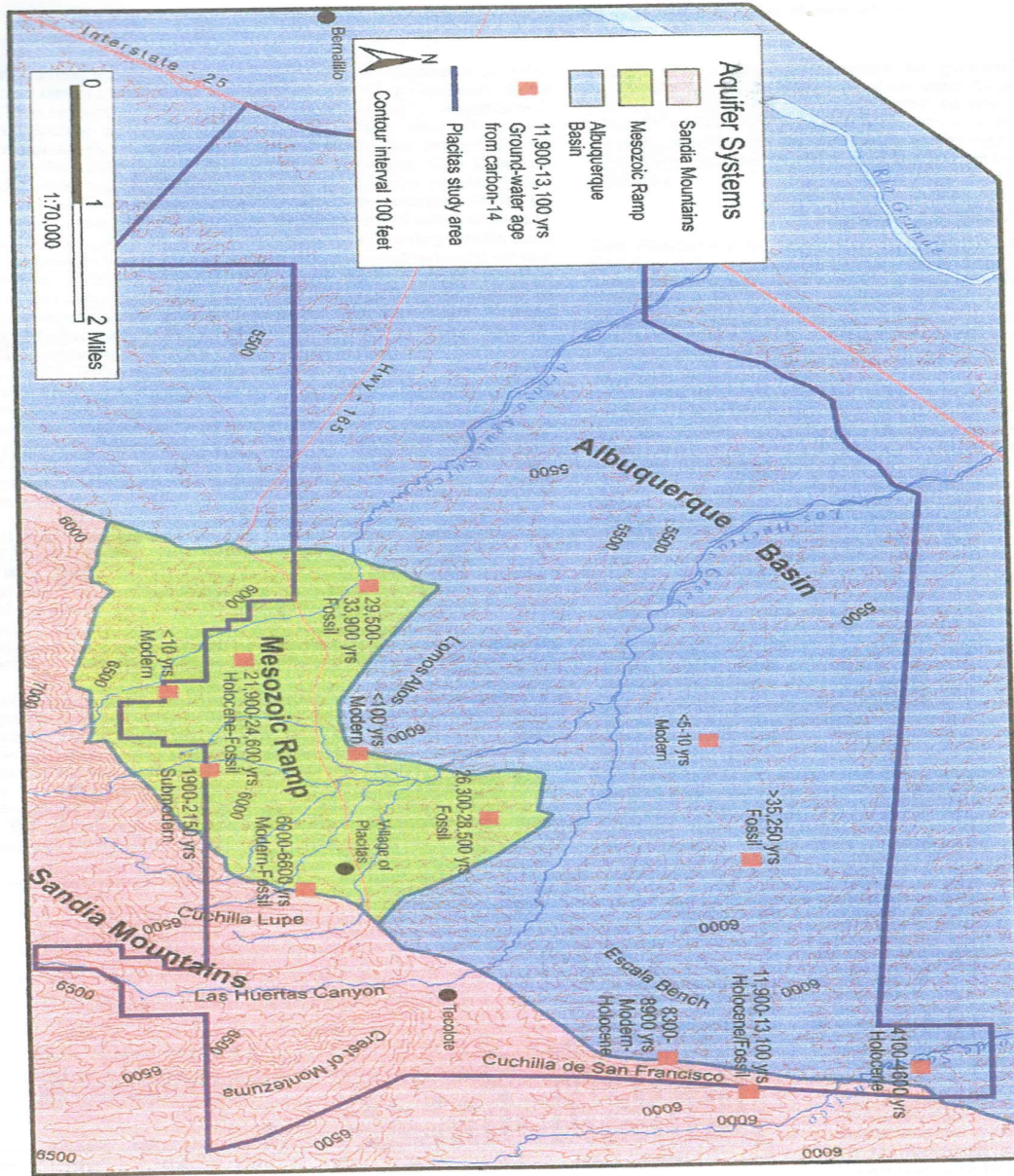
